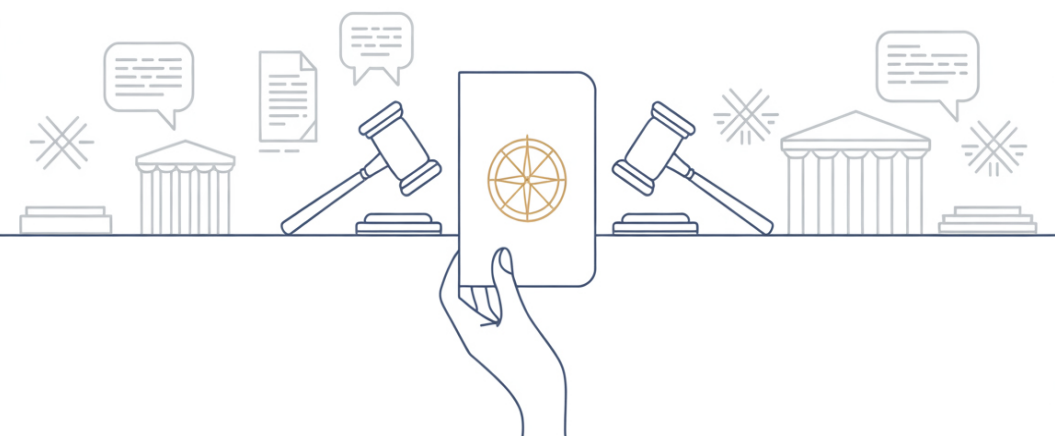

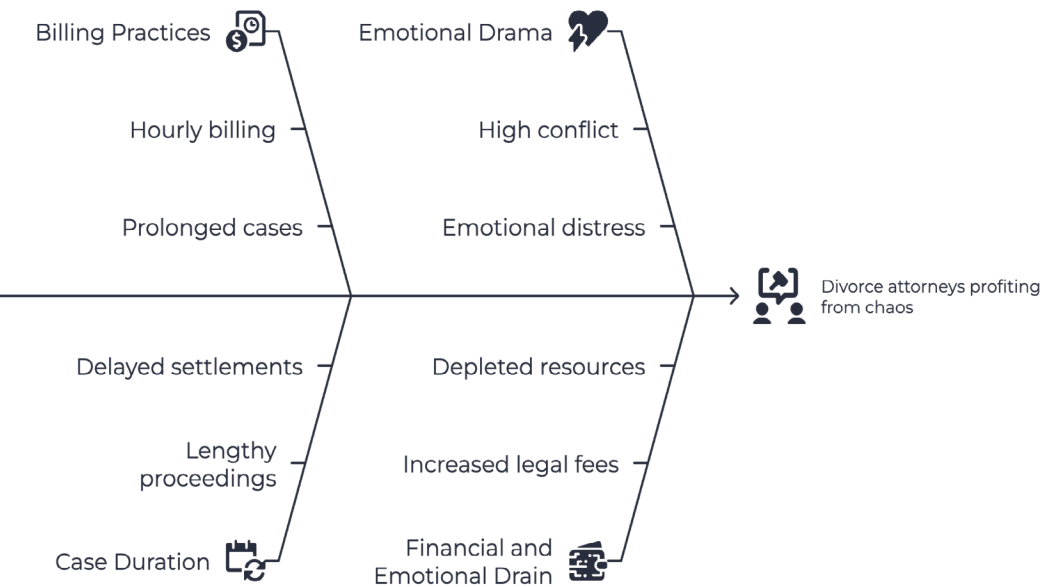

One of the fastest ways to turn a divorce from manageable to miserable is by hiding assets, or even just appearing to.

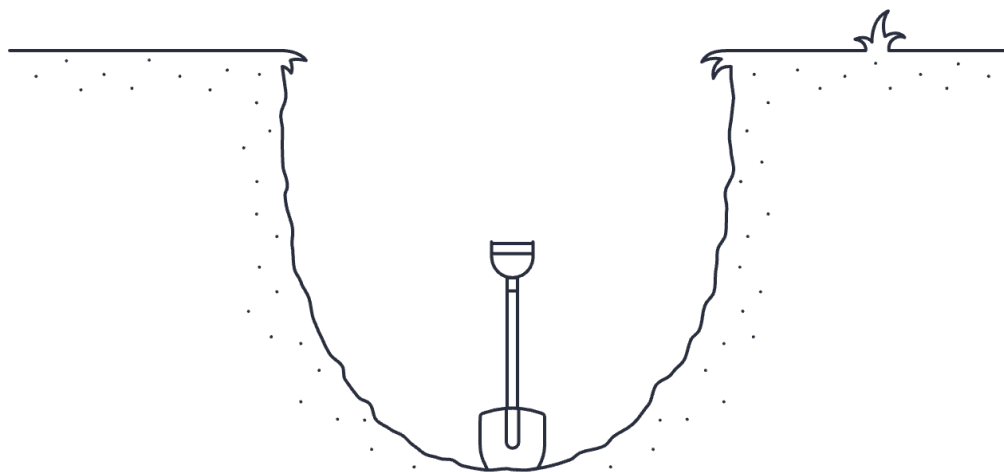
You cannot negotiate in good faith if you hold back information about your finances. Period.

Here's What Happens When You're Not Transparent:

- Trust evaporates. Once suspicion enters the room, so does conflict.
- The lawyers dig in. Incomplete or delayed disclosures force attorneys to chase down documents, request subpoenas, and waste time and money.
- Negotiations break down. When one spouse plays games, the other doubles down. The case slows. Tempers rise. Invoices grow.

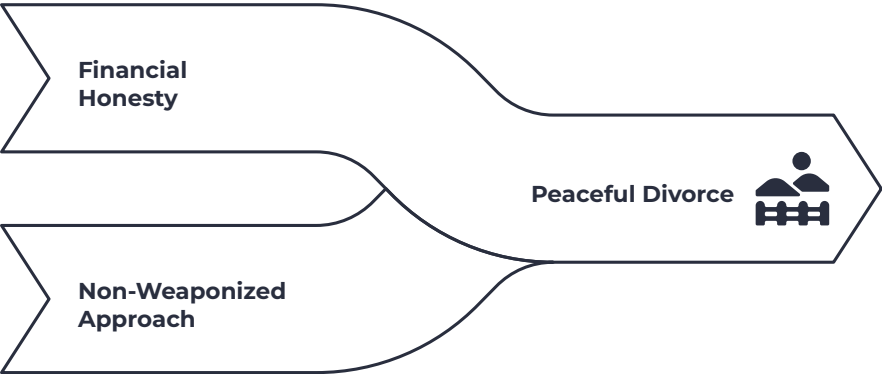

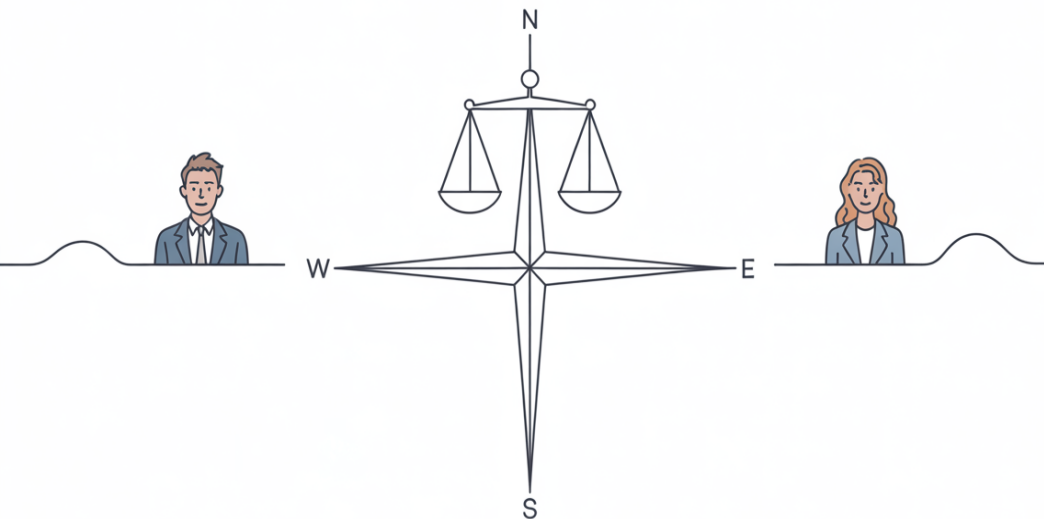

Florida statutes already provide a roadmap for what's fair regarding things like dividing assets, calculating alimony, and determining timesharing. If you ignore that roadmap, you're not navigating. You're wandering.

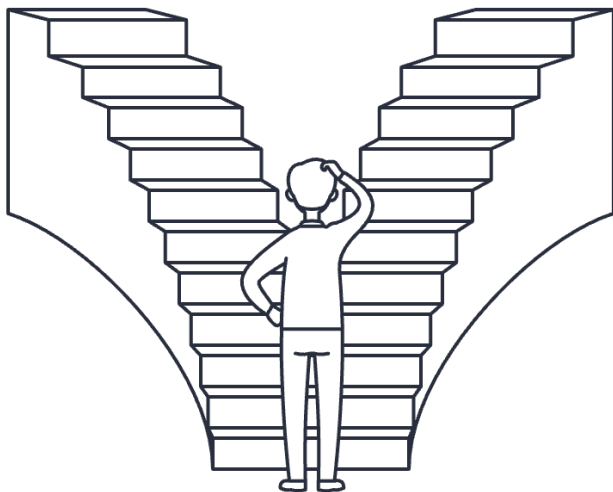
How to navigate the divorce process?

Follow the Law

Ensures fairness and avoids unnecessary conflict by adhering to legal guidelines.

Make Emotional Demands

Leads to disputes and delays by ignoring legal standards.



Here's Where People Go Off Track:

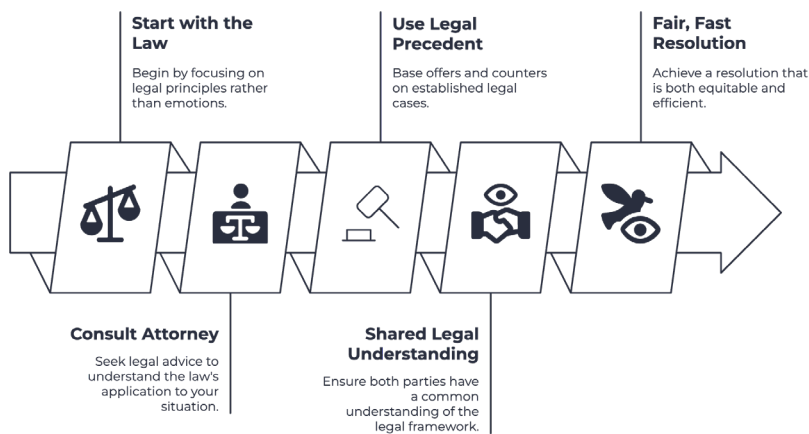
- They fight over **what they feel is fair**, rather than what the law says.
- They treat **non-marital assets** (like pre-marriage inheritances or business interests) as if they're up for grabs.
- They assume they can negotiate from emotion instead of legal grounding.

TRUTH: Florida law views marriage as a partnership. Income earned during the marriage is typically a marital asset, regardless of who earned it.

MYTH: "Because they cheated, I should get everything."

TRUTH: Florida is a no-fault divorce state. Infidelity rarely affects asset division unless it has a financial impact on marital resources.



Infidelity justifies all

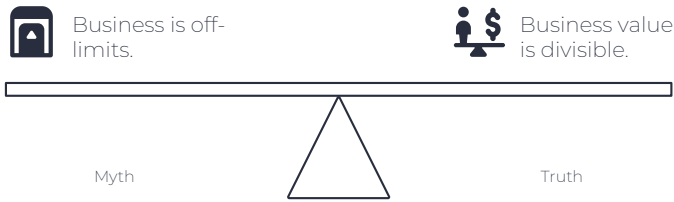

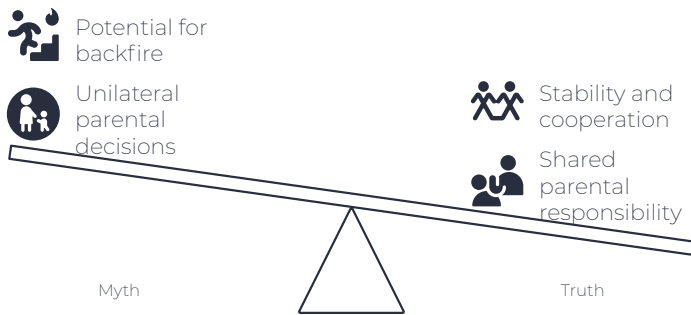
MYTH: "My spouse's business is completely off-limits because it's in their name."

TRUTH: If the business grew during the marriage or was supported by marital funds, part of its value may be subject to division.



MYTH: "I can just move out with the kids. I'm the better parent."

TRUTH: Unilateral decisions about children can backfire. Florida courts prioritize stability, cooperation, and shared parental responsibility.



MYTH: "I'll get more if I let the judge decide."

TRUTH: Going to court means giving up control. Judges apply the law, not emotions. Settling outside of court gives you a say in the outcome.

A surprising number of divorce battles come down to one thing: Someone making demands. My first job out of law school was at the State Attorney's Office. I worked as a prosecutor and had a great mentor who drilled one thing into my head:

"Facts win cases."

He was right then. And after years of family law practice, I can tell you he's still right.

If you don't have the facts on your side, you're playing from behind. And in divorce, that means higher costs, longer battles, and more pain.

Why do so many divorces go off the rails?

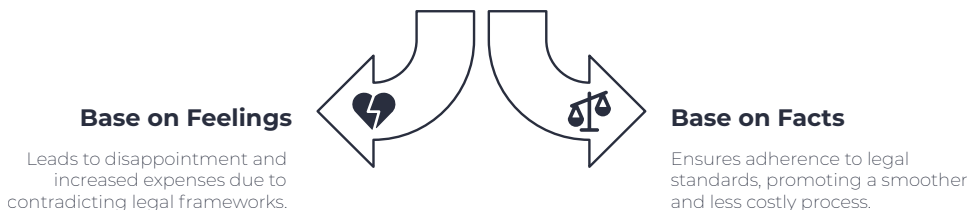
Because one or both parties start making decisions based on feelings, not facts.

And more often than not, those feelings contradict the law.

Divorce law in Florida isn't vague. It spells out exactly how to divide marital property, how to calculate alimony, and what judges consider in custody and timesharing.

If you choose to ignore that legal framework and start negotiating based on hurt, anger, or what you "deserve," you're setting yourself up for disappointment and probably a lot of expense.

– Judges look at parenting capacity, not personal betrayals.

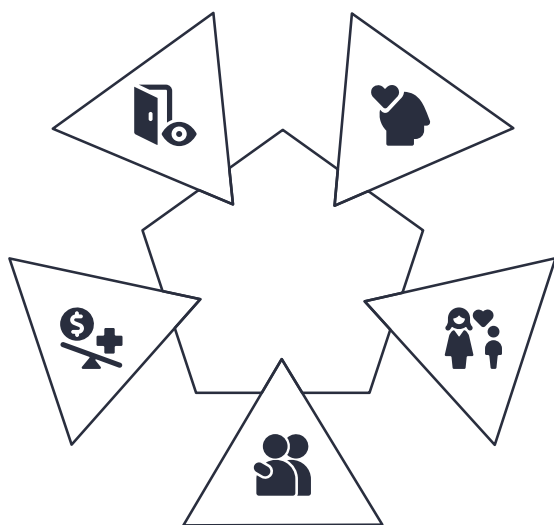
"I sacrificed everything for this marriage."

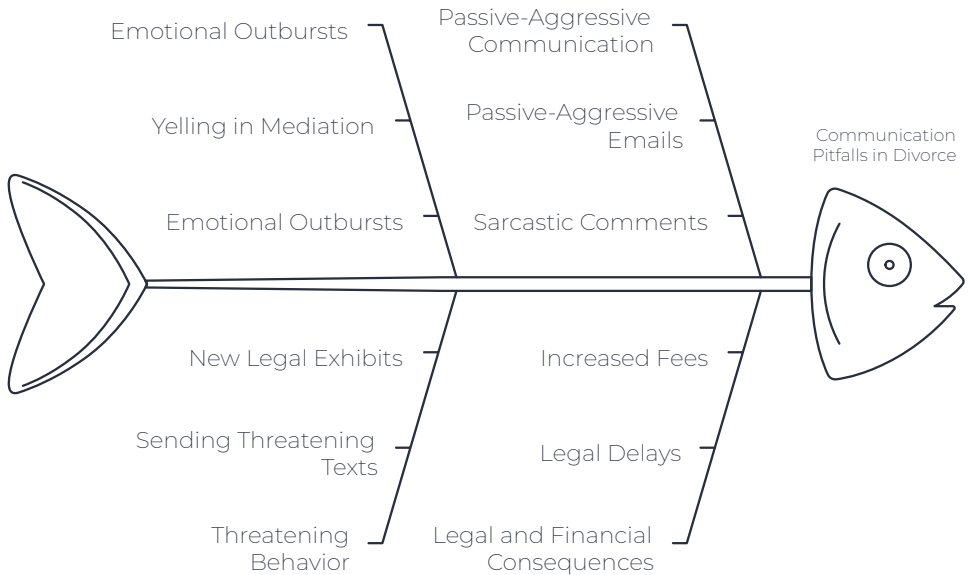
To get to a resolution, you need one key skill:

I've seen it too many times:

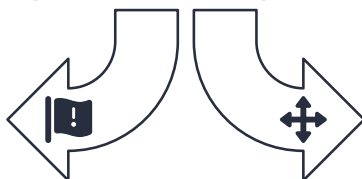
Inflexibility on the small stuff is a red flag.

It usually means someone's operating from emotion (not logic) and that's when the case unravels.

How to approach minor disagreements during divorce?

Inflexibility

Leads to stalled or escalated conflicts over trivial issues, hindering progress.



Flexibility

Allows for smoother negotiations and quicker resolutions, maintaining a calm process.

Flexibility Isn't Weakness. It's Strategy.

- **When you bend on something minor**, you give the other party space to reciprocate.
- **When you stand firm on everything**, you signal that you're not negotiating; you're trying to win.
- **And when one person tries to win every point**, the only guaranteed losers are the kids and the bank account.

Let the Small Stuff Go:

- Child exchange locations? Don't go to war over traffic patterns.
- Furniture? You'll replace it. Let it go.
- Holiday schedules?
Compromise now = peace later.

Ask yourself:

"Will this matter six months from now?"

If the answer is no, it's probably not worth fighting over.

Don't let your pride cost you peace. Save your energy for what really matters.

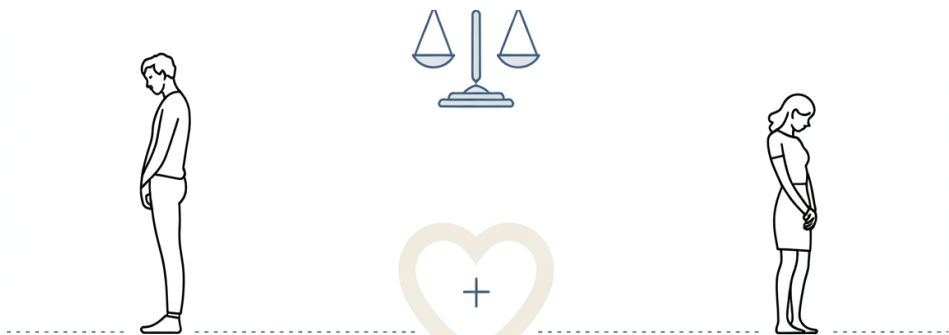
What to Flex On vs. What to Hold Firm

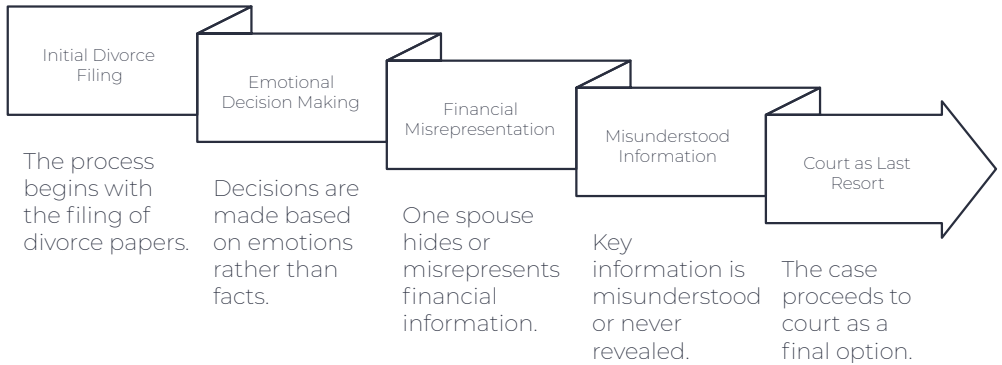
You're Not Supposed to Do This Alone. Build Your Peace Team.

Therapists

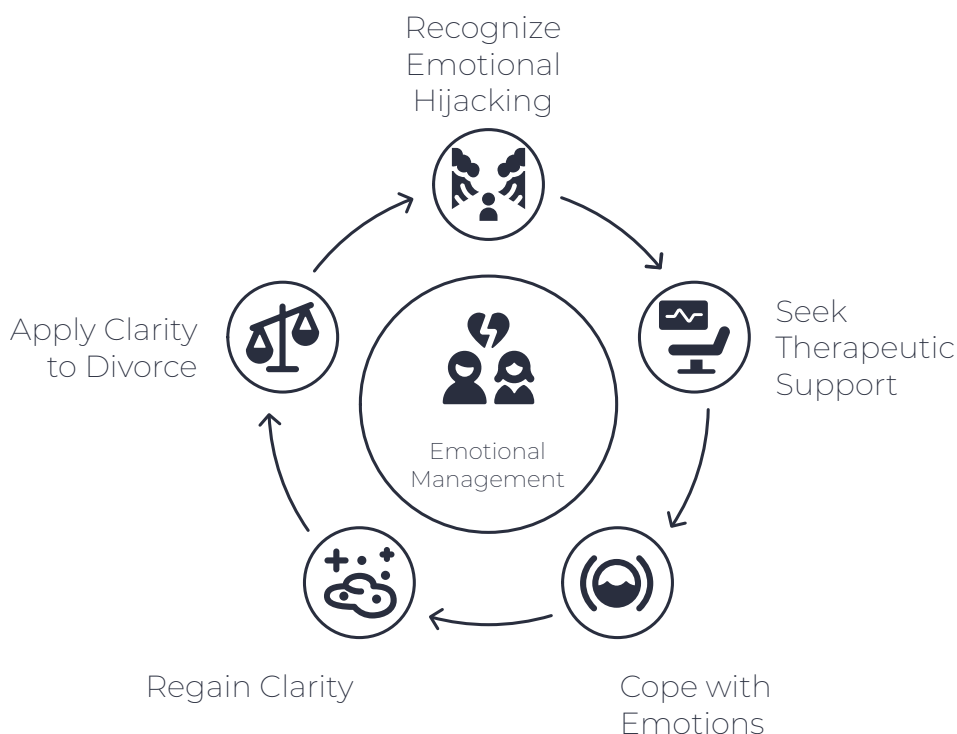
When emotions are hijacking your judgment, a therapist can help get you centered.

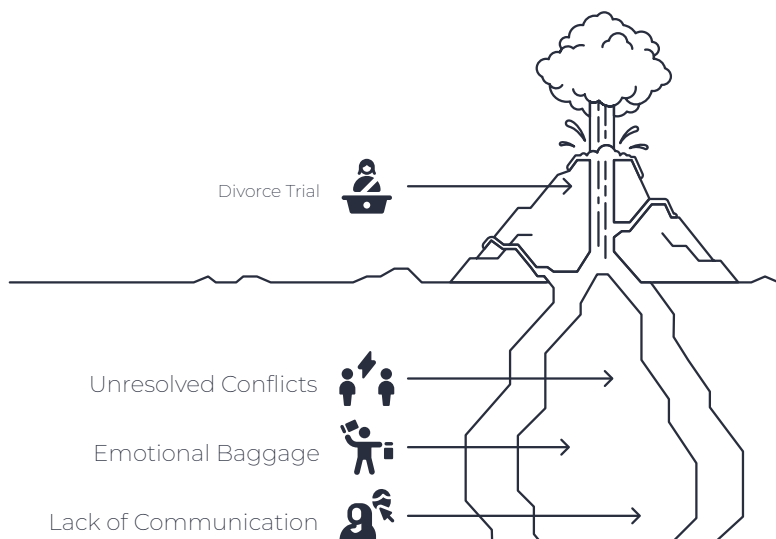

Cases? Emotional time travel.

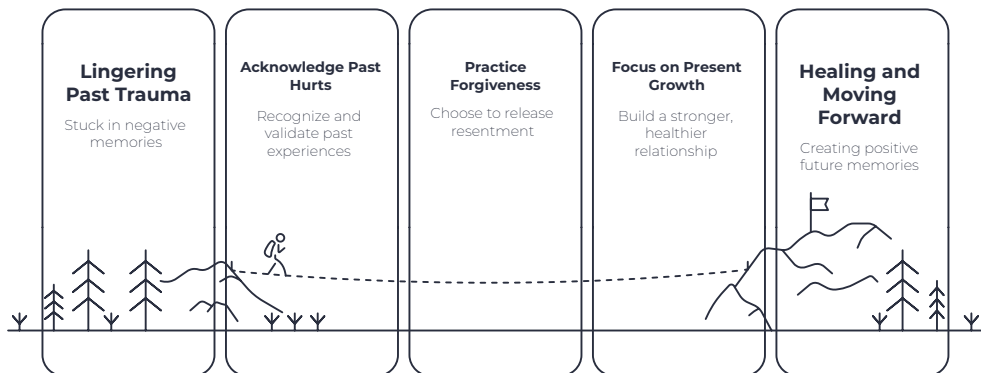
One or both spouses get stuck reliving-

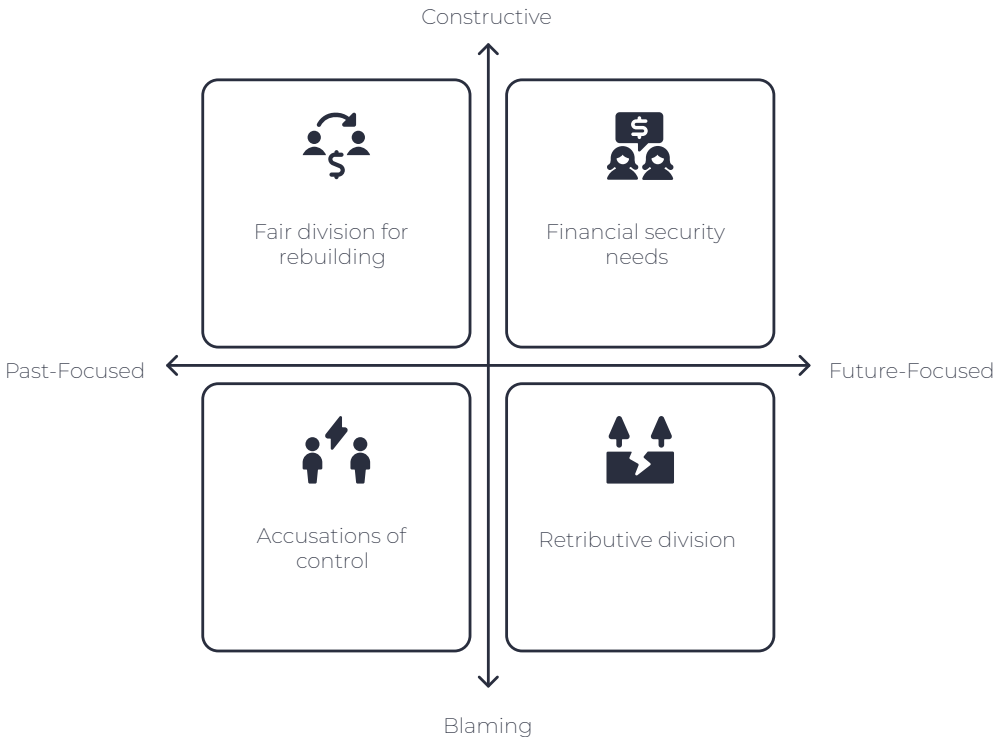

Looking forward moves me on."

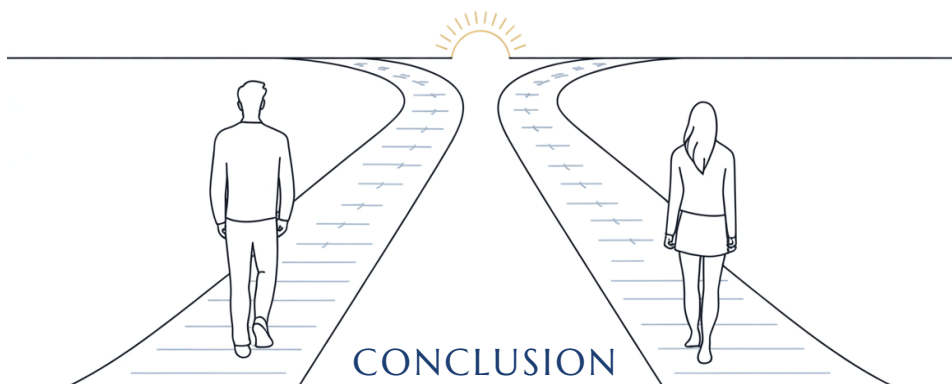
Letting Go Isn't Forgiveness.
